Toltec School District Policy Open Enrollment Policy

Toltec School District serves children, grades K-8, residing within the Toltec School District school boundaries. Children who reside outside these school boundaries must request an Out of District waiver as per the Open Enrollment Policy.

Parents who are considered moving into or out of the district are encouraged to contact the school office to determine school boundaries.

- ❖ A request must be submitted annually by June 1, prior to the following school year, to determine whether capacity exists at each grade level to accept out of district students.
- ❖ Students may be denied admission to renewal of open enrollment on the basis of their disciplinary, academic or attendance records.
- ❖ The governing board authorizes the Superintendent to place out of district students on probation if the student violates any portion of the disciplinary, academic, or attendance requirements.
- ❖ A student who is accepted in the Toltec School District is accepted for the current school year only. A renewal application will be considered based on the same admission standards as the original application.
- ❖ Students who move out of the school district during the school year must request to continue attending school in the Toltec School District by completing the Open Enrollment Application, within 30 days of moving out of the school district.
- ❖ If maximum capacity numbers are approaching, Toltec School District employees have first priority; students who have attended the Toltec School District for the entire previous semester will have second priority; and if additional capacity exists, a lottery of eligible new students will be held to determine who is approved.
- ❖ No transportation will be provided for out of district students. Safe and timely transportation is the responsibility of the parent or guardian.
